City Managers report

City Manager Potts stated that the Landfill is making slow and steady progress but will not make the estimated date of January 3rd, 2023. Last week at the landfill a methane probe was drilled to monitor the methane gas. Planning to replace the regulator, parts ordered have come in and put together and now scheduling it in. The 9 tax deeds received last October, 4 of them have been reverted back to the City. The investment company asked for a list of needed repairs to be submitted to their lawyer to try to obtain the deeds back. TCG prepared the list, that was approve by us and have sent it over to them. The other 5 will have until December 23rd. 2022 South Madden demo timeline is coming up and TCG will help us follow back up with the owners.
