(2) be 18 years of age or older on the first day of the term to be filled at the election or on the date of appointment, as applicable;	
<ul> <li>(3) have not been determined by a final judgment of a court exercising probate jurisdiction to be:</li> <li>(A) totally mentally incapacitated; or</li> <li>(B) partially mentally incapacitated without the right to vote;</li> </ul>	

- (4) have not been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities;
- (5) have resided continuously in the state for 12 months and in the territory from which the office is elected for six months immediately preceding the following date:
- (6) on the date described by Subdivision (5), be registered to vote in the territory from which the office is elected; and
- (7) satisfy any other eligibility requirements prescribed by law for the office.
